Principal Activity

The principal activity of the company remains the maintenance of the communal parts of the property known as Astormile Limited, Brookfield Close, Chineham

Prior Year Restatement

The company has no income or expenditure in its own right, all transactions in the year being related to the maintenance of the common parts in accordance with the lease. Service charges collected are held on trust for the purposes of meeting the relevant costs in relation to the properties in accordance with the provisions of section 42 of the Landlord and Tenants Act 1987

During the year the directors have become aware of the Technical Release 03/11 "Residential Service Charge Accounts" issued by ICAEW, RICS and ARMA regarding the preparation of service charge accounts. The directors consider that Astormile Limited as an entity falls within its scope and confirms that those values previously accounted for within the company are assets and liabilities held on trust. As a result the directors have removed all assets and liabilities from the statutory accounts which are the responsibility of the trust and has restated the prior year comparatives for the company.




